 - a. Want to cancel your Gift Aid Declaration
 - b. Change your name or home address
 - c. No longer pay sufficient UK tax on your income and/or capital gains
 - d. Change your bank details
2. If you pay income tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.
3. Patrons donating £500 or more who pay higher or additional rate tax **should not claim the relief on £45 of their donation** otherwise the value of benefits returned to Patrons by the Trust exceeds the limits permitted by HMRC.
